

# **Requesting a Certification**

There are two ways to start a request for a DSI Certification. Your employer can initiate the request. You will receive an invitation via e-mail, or you can start the request yourself. If you have received an invitation, please continue to the next page. If you have created an account to start the request process yourself, please go to the page <u>Your MijnDSI environment - Start a request</u> in this guide.

### **Statement of agreement**

When opening MijnDSI, you will be asked to agree with de DSI regulations. This needs to be agreed with in order to start the process of requesting a certification. #### Satement of approval

To use MijnDSI it is important that you are familiar with our general regulations and our privacy statement. You can consult them in the text below. In addition, we ask you to agree on the basis of these regulations with the way in which we handle the information and data you provide. As soon as you agree, the account will be activated in MijnDSI, after which you can start with the certification application. If there is a substantive change in one of our regulations, we will of course draw your attention to this as soon as you log in to MijnDSI.

#### Applying for certification

You apply for certification with DSI. During the application process, DSI assesses whether all information provided is sufficient to issue the certification.

One of the components of the certification application is going through a screening process. This screening is carried out by Validata on behalf of DSI. In order to perform the screening, personal data are exchanged between DSI and Validata. DSI refers to the DSI Privacy Statement, which you can download below. After completing the screening DSI will perform a number of final checks. After this you will receive notification of the outcome of your certification application.

### Invitation

You have received an invitation because your employer or client has requested you, due to the nature of your work, a DSI Certification.

You can begin the request process by clicking on the link in the invitation mail, which may differ from the invitation sent by your employer.

Daarnaast accrediteren we opleidingsprogramma's en examens en spreken we gecertificeerden aan op niet integer gedrag door middel van het DSI Tuchtrecht. DSI wordt breed gesteund door de werkgevers in de beleggingssector, AFM, DNB en branche organisaties. In de afgelopen 22 jaar is DSI uitgegroeid tot een professionele organisatie met een belangrijke stem in de sector.

### Your MijnDSI environment | Start a request yourself


If you have not received an invitation, you can log in to your account or create an account via <u>mijn.dsi.nl.</u> If you want to start a request yourself, click on the **'Start Certification application'** button.

For a certification request a **screening at Validata** is a standard part of the registration process. This is included in the registration request and does not need to be requested separately.

### Your MijnDSI environment | Invitation from employer

Confirming your password will automatically log you in to your account. You can now begin the request process by double-clicking on the request or on the button 'continue the request'.



## What do I need for my Certification?

This screen will appear before you can continue with your request. The page shows which documents and information you need to complete the Certification request as smoothly as possible.

If you are ready to begin the Certification process, click on '**Start New Certification**'.

#### What do I need for my certification?

You have started an (amendment) application for certification by DSI. In order to make the application for your certification go as smoothly as possible, we advise below which documents and data you should have at hand.

Once you have gone through the application with DSI, and DSI has performed an initial check, you will be invited for a screening at our partner Validata. Based on the information you provided and the type of application, it will be determined which parts of the screening you will go through. You will be further informed by Validata.

The email address of a contact person from your current or future employer, for example from your supervisor or HR. This e-mail address is used to verify whether you have 12 months of relevant work experience with regard to the register.

If you have recently been screened by AFM, DNB, DSI and/or Validata, the final screening document of the screening in PDF.

The exam results you have obtained in relation to your certification. In some cases we also ask for a diploma of the exam passed, you will be made aware of this in the application.

#### Starting a Certification yourself


To select the correct Certification process, we must ask you several questions. A Certification will then be suggested based on your answers.

If your employer sent you the invitation, then the register is filled in automatically, so you can skip this step.

In this step, you will enter your contact details in My details. The e-mail address you enter in the designated field is the address your employer used to send you the invitation. Enter a second e-mail address, preferably a private address, in the field for the alternative e-mail address.

You can always use your private e-mail address to access your account and details, for example if you leave your current employer and no longer use your work e-mail account.

### **General Data** | Agreement and verification

We request your current or future employer to confirm whether you have 12 months of work experience in regards to the specific register. We request this, since to be fully certified,12 months of work experience within the last 5 years for the specific register are a requirement. Fill in the name and email of the HR manager or your supervisor at the a forementioned company. As soon as you go to the next step an email will be sent to the email to confirm the work experience.

# **Earlier screening**

In this step u can state whether in the past year you have been screened. DSI accepts AFM, DNB, Validata or DSI screening reports. Please upload a Screening Report in this step (if applicable). DSI will check the uploaded report as soon as the certification has been sent in. If the report is accepted, a full screening at Validata is not required.


Be aware: The screening report is not allowed to be older then <u>a year</u>.

# **Exams**

To be fully certified by DSI, it is important that you have successfully completed exams for knowledge, skills and integrity. In the request, you can state which exams for the specific register you have already completed, when you completed them, and the education institution where you took the exams. In some cases uploading a diploma will be requested.


It is not a problem if you have not yet successfully completed all of the exams. You can always complete them at a later date. In the meantime, you will be registered as a Candidate Certified.



### **Submitting a request**

You have now arrived at the last step for DSI. Once the button **"Submit"** is pressed, the request will be submitted to DSI and DSI will do the first check. After this check an invitation by Validata will be sent, so you can start the screening process.

Are you sure all the information is correct? You can always check the steps once more in order to check it. If all the information is correct, then click on 'Submit'.



### Screening Validata | Start screening

After the check of DSI, you will receive an invite for a screening at Validata. In the invitation text (see example), you can start the request by clicking on the link in the text.

The next steps can be part of the screening proces: ID/passport, highest obtained education, work experience, VOG (certificate of conduct) and a DSI integrity questionnaire.

On average the screening takes 10 workdays.

### **Screening Validata** | receiving screeningreport

You have a limited time periode to finish the screening. You will be periodically be reminded to finish the screening. If there is no response, the screening can be deactivated. Validata deletes all information from deactivated requests within 90 days.

After succesfully finishing the screening you and DSI will both receive the screeningreport.

### **Check received data**

After finishing the screening both you and DSI will receive the screening rapport. DSI will check the data. If everything seems in order the certification request will be accepted. Depending on the passed exams and work experience for the specified register, you will now be DSI candidate-certified or DSI certified.



# **Finalizing**

You will receive an e-mail with the result of your certification request. Depending on your status (candidate-certified or certified) you will be added as such to the <u>DSI Public Register</u>.
