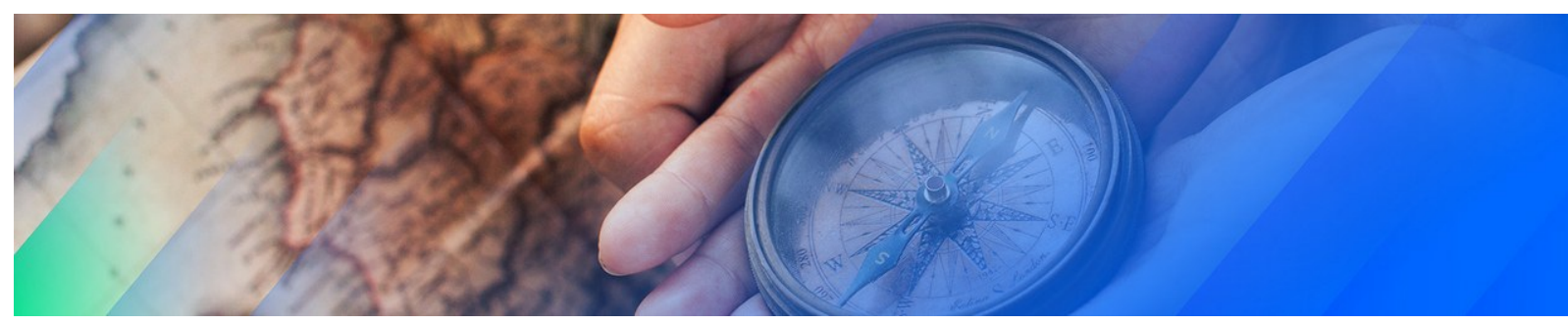

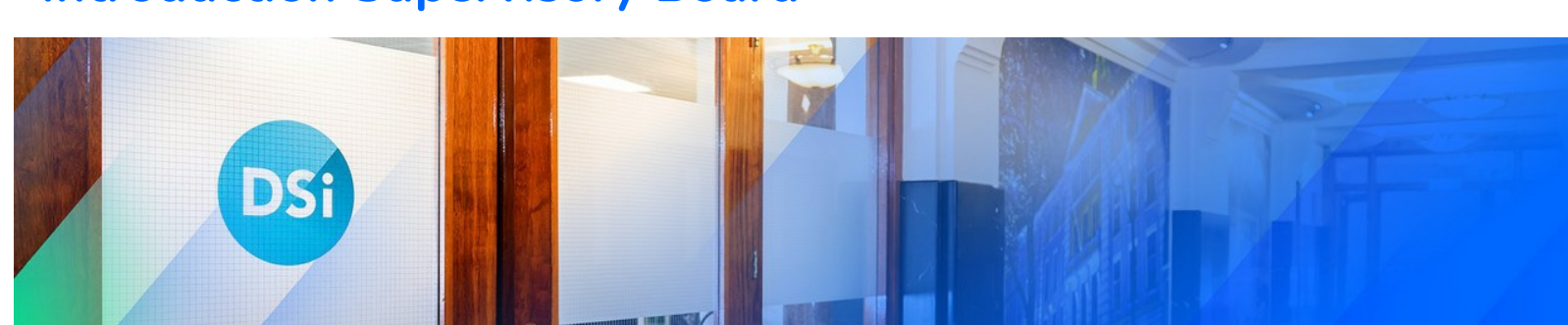
Development of DSI AML Register

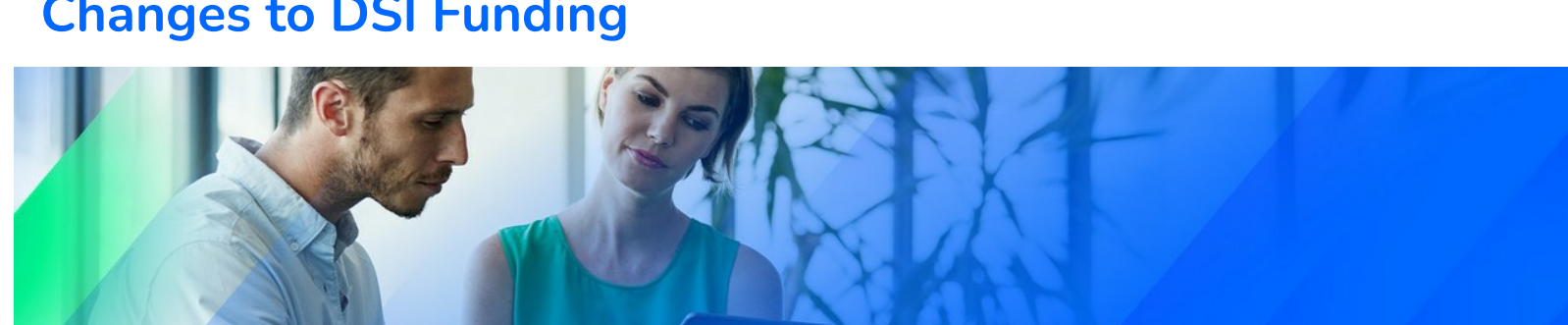
Overview DSI Participants

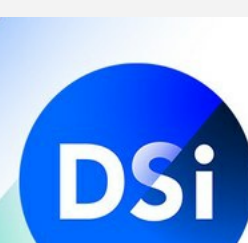

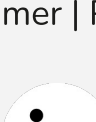
